As a designated and successful Tribal Health Program (THP) under P.L. 93-638, FDIHB has the ability to become even more mobile and flexible to meet the needs of our patients we recover from this pandemic. We focus in on creating independence for our community, in our own facilities, to maintain the proper level of readiness for any future healthcare crisis.

FDHIB has established a drive-up COVID-19 Clinic that specializes in COVID-19 testing and vaccination. See below for schedule:

Important Information:

- All children <u>MUST</u> be accompanied by their parent or legal guardian.
 - Legal guardians <u>MUST</u> present guardianship papers or official court documents of guardianship.
- Individuals receiving their 2nd dose are required to provide their Vaccination Record Card to the attending vaccination team.
- Individuals who receive a COVID-19 test will be required to isolate until results are communicated by TMC Public Health Nursing.

The Pfizer-BioNTech COVID-19 vaccine is currently the only COVID-19 vaccine authorized for individuals 12 years old and older. The COVID 19 Vaccine is **not** recommended for patients who have the following:

- Individuals younger than 12 years old at the date of vaccination for Pfizer vaccine.
- Individuals younger than 18 years old at the date of vaccination for Moderna Vaccine.
- Have cough, fever, shortness of breath or loss of taste or smell, or any other illness.
- Are currently in isolation for positive COVID-19 test results



- Are currently in quarantine for a household member with COVID-19 or an exposure to a person who has COVID-19.
- Currently waiting to receive COVID-19 test results.
